- **Number of Aboriginal and Torres Strait Islander** students long suspended in 2014: 3,168



Suspension and expulsion data by Department of Family and Community Services districts



Previously, suspension and expulsion data was published by region and school education group. Changes to the Public Schools NSW regional structure from the beginning of 2013 required a different reporting format for the 2013 and 2014 suspension and expulsion data.

The 2014 data is set out in the 15 Family and Community Services districts. Publication of data in this way will assist evidence informed planning and practice across NSW Government agencies.

Data published prior to 2013, in education regions, is not comparable with the 2013 and 2014 data published by Family and Community Services districts.

Please note: From time-to-time, the Department of Family and Community Services may change the boundaries of their districts. Therefore, care is needed in interpreting this data over time.




- 1. In 2010 the school leaving age was raised from 15 years to 17 years.

- 3. In 2013, data was exclusively harvested from ERN making it more reliable.
- 4. Both vertical axes have different scales. This should be considered when interpreting the graph.

Prior to this, expulsions data was recorded on a manual return. This has potentially impacted consistency across longitudinal data.
